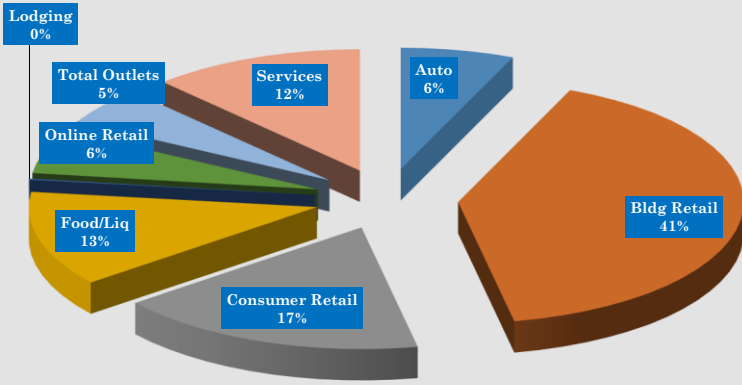
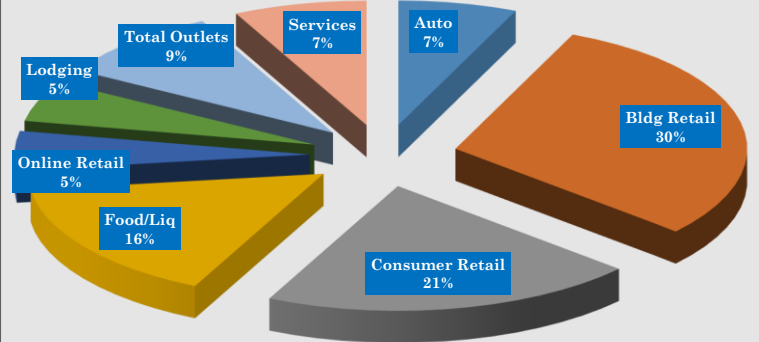

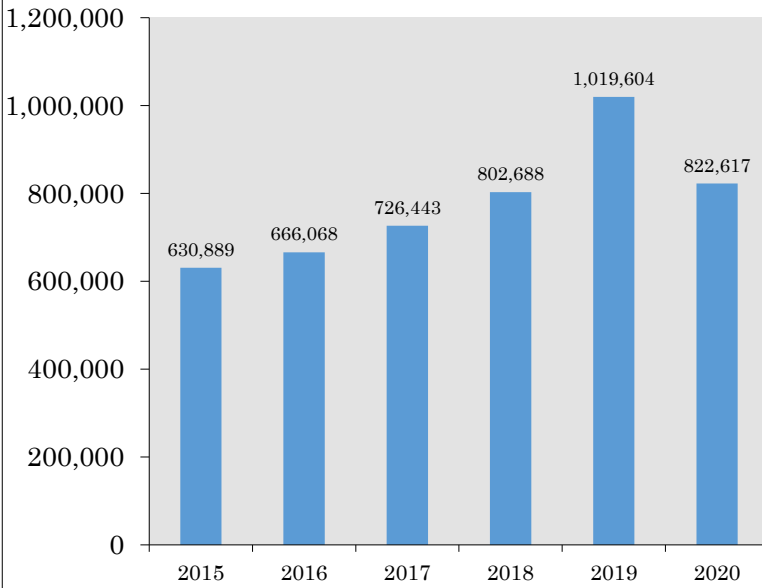
2020 MTD SALES TAX BY CATEGORY



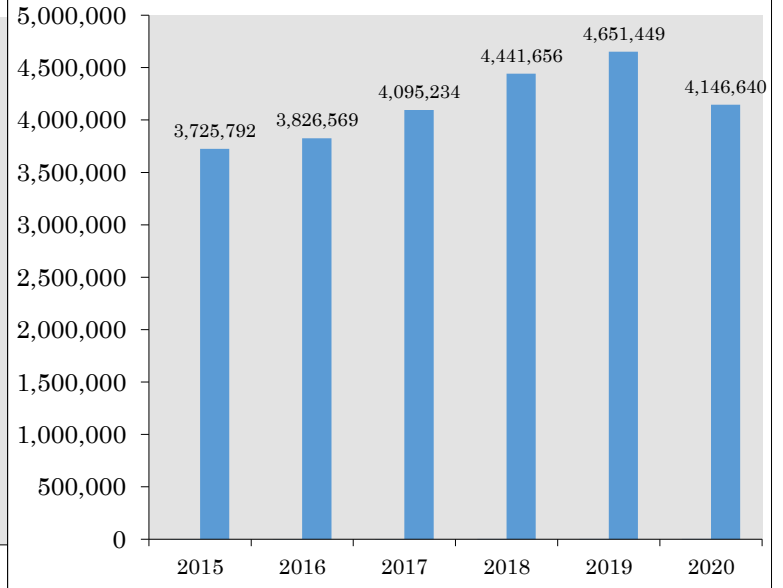
2020 YTD SALES TAX BY CATEGORY

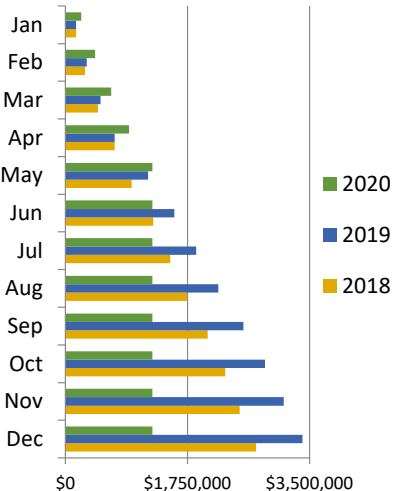

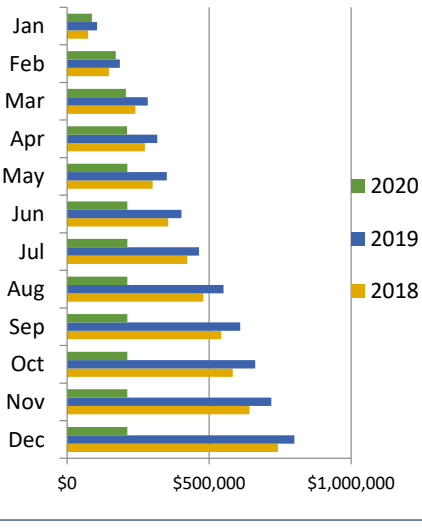

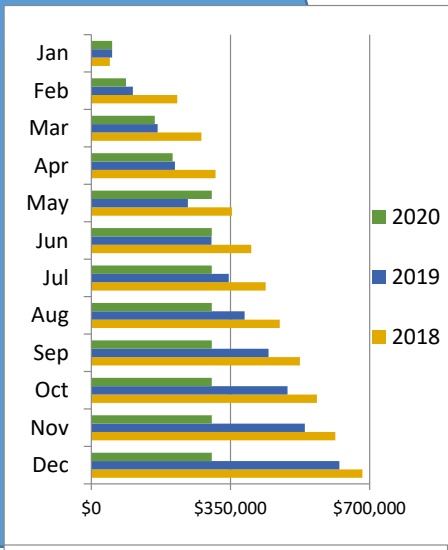
