Sales Tax by Sector

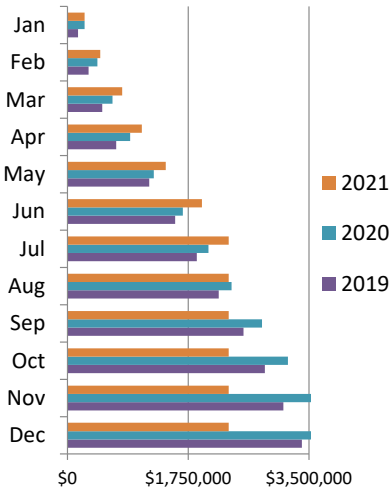

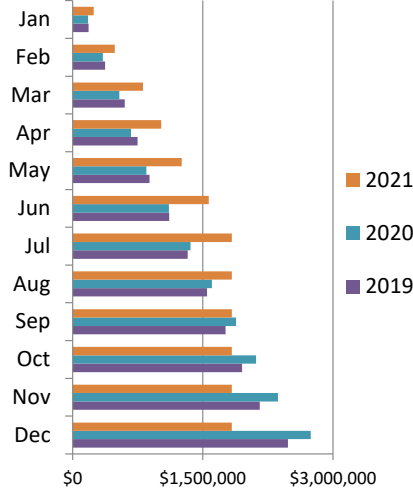

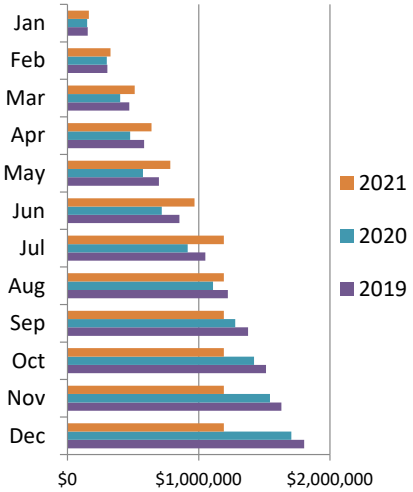

Sales Tax by Sector

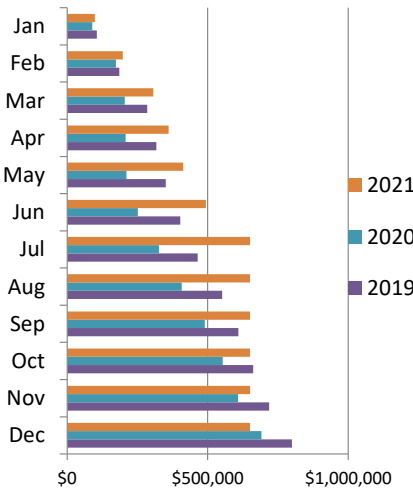
